Once your ENS number has been assigned, you can list the number on the enclosed 911 stickers. Be sure to have the sticker in a visible location for immediate access in case of an emergency.

In order to process your application, a \$45.00 one-time fee made payable to the Emergency Numbering System is required and can be included with your filled out Computer Worksheet and signed Owner's Consent Form. Please place all three items in the enclosed self-addressed envelope and return to our office.

We will be making contact with the ENS representative in your area to assist with the assigning and placement of your ENS sign at your property. Please be aware that this may take 4-6 weeks to complete this process.
